

RRCT HOLDINGS AND STEWARDSHIP AS OF JULY 1, 2016

Summary:

- RRCT owns eleven preserves in five towns totaling 489 acres. The management of these preserves is integrated with the ownership of nearby conservation owners, and enhanced by conservation easements and other lands. Some preserves are showcased with trails and trailheads, others are not promoted but rather held quietly for habitat.
- RRCT is the holder or steward of nearly 2900 acres of private and municipal land protected forever from development through 40 different conservation easements in eight different towns, often abutting or connected to a larger conservation landscape.
- RRCT has assisted in major expansions of Bradbury Mountain State Park, the Pineland Public Reserved Lands Unit, Maine DIFW wildlife management areas, town parks, and more.
- RRCT stewards conservation easements on seven properties with active agriculture or farming; agriculture is allowed on three additional properties with RRCT conservation easements.
